# Other lately published releases

<u>9 December 2024</u>: Kalmar has supplied APM Terminals with a Kalmar electric reachstacker to be piloted at Suez Canal Container Terminal (SCCT). The order, booked in Kalmar's Q3 2023 order intake, marks a significant step in both companies' commitment to advancing the electrification of terminal operations. APM Terminals and Kalmar will work together to collect data and insights from this pilot, with the goal of advancing the electrification of terminal operations across the industry.

<u>27 November 2024</u>: Kalmar partners with Elonroad, a Swedish cleantech company specialised in automatic charging technology for heavy vehicles, to build a 200-metre electric road for charging electric vehicles. The electric road, to be built at Kalmar's Innovation Center in Ljungby, Sweden, enables electric vehicles to be charged dynamically both while moving and stationary through rails in the ground. This innovative solution would reduce the need for large batteries onboard the vehicles and grid capacity, while improving vehicle uptime.
